**BUILDING TRUST IN ORGANIC CONTROL SYSTEMS FOR BETTER TRADE
RELATIONS: A MEDITERRANEAN PERSPECTIVE**

Skopje, 15-17 May 2012

BACKGROUND

The 6th MOAN meeting will be held in Skopje, MKD on 15-17 May 2012. As usual, it will be a three-day meeting including one-day international workshop, one-day session devoted to the presentation of the organic sector of the hosting country and to a technical visit and an internal Network meeting for updates and discussion of the following activities.

Building on the outcomes of the 5th MOAN meeting held in Tunisia in 2009 (<http://moan.iamb.it>), with the help of international experts and the contribution of Network members, the first day international workshop will focus on institutional trust building mechanisms in trade relations, addressing, more specifically, some timely issues like:

- ✓ EU Member States' concern for quality of controls in Third Countries and competition of organic imports from Third Countries flooding the domestic and EU markets;
- ✓ Mediterranean Third countries' interest for barriers reduction in organic trade (i.e. easier access to EU markets) and capacity building in the interaction with EU and MS institutions;
- ✓ some Mediterranean Third countries' interest in setting up an organic market supervision and surveillance system to allow for diversification of the product range in the national organic market;
- ✓ all Network countries' interest in creating and consolidating good (extra- and intra-regional) trade relations based on reliable and transparent control systems, reliable data on organic trade and effective communication mechanisms.

OBJECTIVES

With a specific Euro-Med geographical focus the international workshop aims to:

- ✓ provide participants an overview of governmental rules and schemes affecting organic trade relations;
- ✓ deepen the understanding of roles and challenges of Competent Authorities in organic controls to build better trade relations;
- ✓ share knowledge and experience about existing (good and bad) practices and lessons learnt in irregularities/infringements management, communication (formal and informal) procedures and organic trade data management;
- ✓ discuss opportunities for public-private collaboration in organic controls;
- ✓ identify areas of common interest for drafting cooperation projects.

EXPECTED OUTCOMES

- ✓ Improved understanding among Network members of challenges and opportunities associated to rules and schemes affecting the organic trade.
- ✓ Identification of best practices in organic market supervision and surveillance and data collection for future reference in: *i)* developing national organic systems; *ii)* drafting institutional agreements; *iii)* designing cooperation initiatives.
- ✓ Fostering partnerships between North and South as well as among Southern Mediterranean countries for a better trade of organic products.
